1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a limited assurance review is set out by the National Audit Office (NAO). A limited assurance review is not a full statutory audit, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it does not provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

2 External auditor's limited assurance opinion 2023/24

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR)
n our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our
attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review:

The smaller authority has not addressed the 'except for' matter raised by the external auditor when qualifying the prior year annual return. The prior year Section 2, Box 9 figure has not been restated to include all fixed assets purchased in 2022/23.

Section 1, Assertion 2 has been incorrectly completed. Information received from the internal auditor has highlighted significant weaknesses in respect of systems relating to Hall hire and cemetery income as well as a systematic payroll calculation error. This is consistent with the Internal Auditor's responses to Internal Control Objectives E and G. As a result, this Assertion should have been answered 'No'. The smaller authority should ensure that these weaknesses are addressed in a timely manner.
