The Committee discussed the current provision of grit bins and grit sand the council currently has. Conclusion was that one grit bin is needed in a dry place such as a commercial Memorial Hall car park. Grit is needed to be stored in a dry place such as a commercial council garage. Clerk to investigate grit/grit bins and storage, and any funding that there may be. Clerk mentioned the council adopting a cold/snow weather policy.

The council are unhappy with the current planting in the flower beds this winter. The working group will hold a meeting if we decide to continue with the current supplier for the year ahead.

RE/2025/010 To note an update on the noticeboards and consider any further action

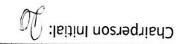

Cllr D Oxley will accompany the highways inspector from Rotherham council when he comes to assess the situation.

# RE/2025/013 To receive the latest Playground Inspection report and consider any further action

The recent playground inspection reports from Monday 13<sup>th</sup> January 2025 were discussed. The roundabout at Brampton has been raised from low risk to moderate risk.
