### FE/2025/056 To receive an update from the ongoing meetings with architects regarding the remodel of the Gordon Bennett Memorial Hall.

Cllr McCartan and A. Stockham have had meetings with 3 different architects regarding the remodel. 2 quotes have been received so far.

**Resolved:** Once all 3 quotes have been received an extraordinary meeting will be called to discuss further.

#### FE/2025/057 To review the fees for the hire of the Gordon Bennett Memorial Hall.

**Resolved:**- Council proposed to keep the prices for regular users the same for financial year 25/26.

A recommendation was put forward for adhoc bookings as follows:

Hourly rate to increase from £20 to £25

Bar service to increase from £20 to £25

Bouncy castle electric to remain at £10

Full day booking to increase from £150 to £170

Full week booking to increase from £500 to £600 + £120 per extra day

Elections to remain at £400

Hire of the council chambers to increase from £10 to £15

This proposition will go through the finance meeting 19/6, then full council 26/6.

**Voting:**- 5 councillors present. All councillors voted in favour.
